On the above mentioned subject, it is intimated that last date for online  
 filling of Scholarship applications by the students on National Scholarship Portal under various  
 Centrally and State sponsored scholarship schemes in the current Academic Session 2024-25 has  
 been extended upto 18-11-2024.

In this regard, one more opportunity is being given to all the students who  
 wants to apply for scholarship (according to their eligibility) in the current academic session  
 2024-25 under Centrally or State Sponsored Scholarship Scheme, to fill their scholarship  
 application online on National Scholarship Portal on or before 18-11-2024, positively.

Further, the Heads of Educational Institutes as well as Institute Nodal  
 Officer Scholarship are directed to ensure to verify / re-verify all the scholarship applications /  
 defective scholarship applications in all schemes within the prescribed timeline. It must also be  
 ensured by HOD and INO Scholarship of the Institute that no scholarship applications of any of  
 the student(s) be remained unattended/ defective in the Institute Login ID. It must be noted that

no further extension for registration and filling of scholarship applications and verification of scholarship applications on the portal will be extended to disburse the scholarship amount well within timeline to the students who have apply for scholarship well in time. The applicants who have followed the timeline for filling of scholarship applications could not be deprived of scholarship at the cost of defaulters.

The Deputy Directors of Higher Education in the State are directed to issue necessary instructions to all the Principals / Headmasters, Govt. and Private Sr. Sec./ High Schools in their District to guide the students and verify all the scholarship applications accordingly at Institute Level (I-I Level) as well as District Level (I-J Level) within the prescribed timeline accordingly, please.
