Self-Financing courses BCA/BBA/PGDCA

Bachelor of Computer Application (B.C.A.), Bachelor of Business Administration (B.B.A) & Post Graduate Diploma in Computer Application courses are run by the College under Self-Financing Scheme. The duration of both the courses (BBA/BCA) is three years (Six Semester) & PGDCA is one year (Two semester).

ELIGIBILITY FOR BOTH THE COURSES: (BBA/BCA)

Candidates who have passed 10+2 examination from H.P. Board/CBSE/ICSE or any other examination considered equivalent to 10+2, by the Himachal Pradesh University, Shimla-5, with 50% Marks (45% marks for SC/ST category) OR

Any examination of University/Board/College/School in Foreign Country recognized as equivalent for the above purpose by equivalence committee of its own or on recommendations of Association of Indian Universities with 50% marks (45% marks for SC/ST) shall be eligible on merit basis.

ELIGIBILITY CONDITIONS (PGDCA)

Bachelor Degree in any discipline with at least 50% marks (45% marks in case of Scheduled Caste/Scheduled Tribe Candidates) from a university established by law in India.

AGE LIMIT PGDCA

The maximum age limit for PGDCA course is 26 years (28 years for girls) as on 1st July of the years concerned.

However, in case of candidates belonging to scheduled castes / scheduled tribes, there will be relaxation of three years. The Vice-Chancellor shall have the power to permit age relaxation for reason to be recorded in writing up to a maximum of six months.

GENERAL RULES FOR ADMISSION:

- 1. Admission to various classes of BCA/BBA /PGDCA will be made on the recommendation of the admission committee.
- 2. Candidates must produce original certificates at admission.
- 3. Academic gap must be supported by documents or undertaking.
- 4. Requisite fee must be deposited on admission day.
- 5. If fee is not deposited on time, seat goes to next candidate.
- 6. False information or absence may lead to cancellation of admission.
- 7. Migration subject to vacant seats.
- 8. Admission is not a right; principal may deny/cancel.
- 9. All admissions provisional, subject to SPU approval.
- 10. Compulsory industrial tour for BBA 6th semester.
- 11. Mid-semester migration subject to full fee and security deposit.
